# ■ New major commercial success worth more than 30M€.

MVG (Microwave Vision Group / ALMIC - FR0004058949) announces the signature of a new major contract, worth more than 30 M€ for a measurement system in the Aerospace/Defense sector. The contract calls for delivery in 2023, with a gradual increase in turnover between 2020 and 2023. The Group anticipates a lighter design phase given the skills acquired on similar systems.

This new major commercial success with this customer highlights MVG's know-how and the quality of its products.

MVG is thus strengthening its position in large-scale measurement systems, a market in strong demand, and confirming its ability to sign very significant contracts enabling it to quickly cross important activity thresholds.

At the same time, the Group also booked two orders with an American newspace player for a total amount close to  $\notin$ 4.5 million.

These contracts are part of the order intake for the first quarter of 2020, which is already well oriented, confirming the very good momentum at the beginning of the year.
