It combines MV-Scan[™] high-precision electronic scanners, developed by SATIMO, with ORBIT/FR high-performance, electromagnetic positioning and scanning technology.

This contract follows an earlier award in June, also in the American Defense market, also combining mechanical positioning and MV-Scan[™] technology.
