- An excellent start to the 2019 financial year
 - Strong growth in Q1 revenue: +22.6%
 - New orders increased by a factor of 2.9

The Group continued its positive momentum in Q1 2019 by posting revenue of €18.6M, strong growth of 22.6%, on the back of highly productive, intense activity. At constant exchange rates, guarterly growth reached +16.3%.

The breakdown of revenue by sector remains evenly split between Civil Telecoms (52% of revenue) and Aerospace/Defense (48% of revenue).

The AMS (Antenna Measurement System) branch posted revenues of €13.5M compared to €11.5M in Q1 2018, an increase 17.3%. At constant exchange rates, revenues totaled €12.31M. This performance benefited from the launch of the study phase for a major contract won by MVG in Aerospace/Defense in February and which resulted in Q1 billing (+€1.47M of revenue in Q1 2019).

The **EMC** (**Electromagnetic Compatibility**) branch posted revenue of €4.6M in Q1 2019, compared to €3.2M previously. This strong growth (+45%) is due to new orders in the USA and Europe.

Lastly, the **EIC** (Environnemental and Industrial Control) department maintained stable year-on-year revenue of €0.5M.

New orders in the 1st quarter of 2019 remained generally strong and were boosted by the conclusion of a major contract worth more than €30M over three years in Aerospace/Defense. New orders therefore total €47.7 at current exchange rates (+188%) and €46.1M at constant exchange rates.

Thanks to this very encouraging start to the year, the Group maintains its annual revenue growth trend and continues progressive improvement of EBITDA in 2019.

Earnings for the first half of the year will be published on Thursday, September 26, 2019, after end of trading.
